Reach Academy Pupil Premium Statement

The barriers that are commonly linked with students who are eligible for Pupil Premium are:

- Attendance
- Wellbeing
- Confidence
- Engagement
- SEND

At Reach Academy we have a high intake of students whose attendance is below the national average. Through various supportive programmes we work hard to improve the attendance of all students. PRU-based attendance was 71.81% (Autumn and Spring 2019/20), 5.71% above the national average of Pupil Referral Units of 66.1% (DfE,2018). This decreased to 64.4% during the Spring Term due to the impact of the COVID 19 pandemic.

Wellbeing, confidence and engagement are key factors that impact on our students' engagement upon entry. Through a number of programmes that target well-being (some of which are listed in the attached Pupil Premium Report), we work daily to build pupils' confidence, resilience and engagement in their education.

At the start of a students' placement, a high proportion present with unidentified SEND. Students with significantly complex SEND remain at Reach Academy until their needs are fully assessed and appropriate long-term provision identified. Other pupils on shorter turnaround placements leave Reach Academy with at least one documented cycle of Plan-Do-Review as per the SEND Code of Conduct (2015).

Currently Reach Academy does not receive Pupil Premium funding for children who are dual registered with a mainstream school, and only for those single registered for more than one full term. The school received Pupil Premium funding for 13 students in their 2020/21 allocation.

It is worth noting during 2019/20, 51 of the 74 pupils on roll qualified for Pupil Premium Funding (72.97%). The Actual Pupil Premium grant allocated was £ 7480 for 8 pupils in 2019/20.

Based on the Pupil Premium numbers on roll the full allocation would have returned a grant of £47,685.

Parents of pupils who were eligible for pupil premium funding, and not in school during the Summer term due to COVID-19, were provided with weekly vouchers as per the government schemes. These were emailed or hand delivered by staff depending on home circumstances, including during the holiday periods.

Additional weekly food parcels were also delivered by staff to pupils eligible for pupil premium funding and/or in need of assistance during the summer term.
